2 Identify gaps in MS management.

Questions to Consider

1. Are your employees with chronic diseases such as MS aware of their legal rights and access to special accommodations?
2. Do you offer MS-specific education and support offerings for your employees?
3. Are there opportunities to expand your MS educational and support offerings?

3 Evaluate benefit offerings from your health plan and/or PBM.

3. With a growing number of treatments, do you anticipate changes to how the class is managed (i.e. maintain open access or become more restricted)?
4. Does your pharmacy benefits strategy impact an employees' ability to access MS treatments?
